#### (2) Project Variation Requests for Energy-cum-carbon Audits and Energy Improvement Works (ECPVSC Paper 3/2015-16)

29. The Secretary briefed the meeting about ECPVSC Paper 3/2015-16 which summarized the variation requests for 16 approved Energy Improvement Works (EIW) projects which did not require additional funding from the ECF, and the proposal for termination of an Energy-cum-carbon Audits (ECA) project.

31. After deliberation, Members approved the variation requests for 16 approved EIW projects and endorsed the proposal for allowing the recipient organization of ECP0213 to terminate its project as set out in ECPVSC Paper 3/2015-16.

#### (3) Progress of the ECPNGO Scheme (ECPVSC Paper 4/2015-16)

32. The Secretary briefed Members about the progress of the ECPNGO scheme as at 24 April 2015. In sum, a total of 826 applications were received including 44 energy conservation education projects, 50 ECA and 732 EIW projects. Total funding approved amounted to \$188.95 million for a total of 726 projects, including 32 energy

conservation education projects, 47 ECA and 647 EIW projects. The Secretary further informed the meeting that when all of the approved projects were completed, estimated savings in electricity and reduction in carbon dioxide emissions per annum amounting to 17.36 million kWh and 13,020 tonnes respectively would be achieved.

#### **Agenda Item IV: Building Energy Efficiency Funding Schemes (BEEFS)**

(1) Project Variation Requests for BEEFS  
(ECPVSC Paper 5/2015-16)

33. At the Chairman's invitation, Mr Raymond TONG and Mr SZETO Wing-sum of the Electrical and Mechanical Services Trading Fund (EMSTF), joined the meeting to brief Members about the variation requests for projects under BEEFS set out in ECPVSC Paper 5/2015-16. Mr SZETO informed Members that seven approved applications, viz EEP0307, EEP1147, EEP1215, EEP1266, EEP1312, EEP1459 and EEP1644 under BEEFs had been withdrawn by the applicants, and invited Members' agreement for:

- (a) extension of project completion dates of seven approved BEEFs applications beyond the deadline of 24 months after approval of funding applications, including deferral of project commencement or late submission of completion report, viz EEP0591, EEP0796, EEP0798, EEP1187, EEP1228, EEP1447 and EEP1491; and
- (b) termination of funding for three approved EEP applications, viz EEP1040, EEP1465 and EEP1634 due to lack of progress and no reasonable explanations could be given by the applicant.
